Letters have been sent to the candidates for the current Board vacancy informing them of the scheduled interviews as shown below to be held on Tuesday, August 22, 2017, beginning at 6:00 p.m.

Candidates will be given three to five minutes to make an opening statement. Ten to twelve minutes of the remaining time will be for questioning from the Board. This provides a 5-minute gap between interviews enabling transition and some additional time should a particular candidate response need further clarification. The District Secretary will keep track of time and notify the Board and the applicant when one minute remains in the opening statement and interview.

Upon completion of all interviews, the Directors will individually indicate their ranked choices on a written ballot (Attachment 1) ranking 1 through 4, respectively, after which points will be totaled for each candidate. The General Manager will tally the scoring and read it aloud. Should individual vote information be desired by the Board, candidates or public it will be disclosed. The process will be repeated until one candidate receives a sufficient score prompting a Board member to make a motion for appointment. Appointment of a new Board member requires an affirmative vote by three directors. Once appointed, the District Secretary will swear in the new member. (Attachment 2)
