## **\$50\* Rebate for Swimming Pool Covers**

North Marin Water District is currently offering a rebate up to \$50 to customers for installing a new solar or safety pool cover with non-netted material only.

Please read the Rebate Program Requirements below. Indicate the manufacturer name and model of the swimming pool cover and the purchase price (excluding sales tax and labor) and complete the account and applicant information on the opposite side of this page.

### **PROGRAM REQUIREMENTS**

- Rebate application must be submitted within 90 days of item purchase. An original, dated sales receipt showing itemized costs for the rebated item must be provided.
- Applicant must own or rent a residential dwelling within the District's Novato or West Marin Service Areas.
- Applicant must install a solar or safety cover that is made of non-netted material, with a minimum coverage of 450 square feet area.
- Installation of the rebated item is the sole responsibility of the applicant, as is determined by the adequacy and compatibility of the existing plumbing system. The applicant is solely responsible for proper disposal of all materials associated with the installation of the rebated item and NMWD assumes no responsibility or liability.
- Mail or drop off application with original receipts to District mailing address or office.
- A NMWD representative must be permitted to inspect the property to verify installation if requested.
- Rebate level good through December 31, 2018 or until funds are depleted. Completed application and receipts must be received by January 15, 2019.

### **How can I participate?**

- Install a qualified swimming pool cover.
- Mail in or drop off application along with original receipt for pool cover dated no earlier than January 1, 2018. Application must be **completed and signed**.

- Rebate payment will be mailed to you in 3-6 weeks after application with original receipts are received. Post inspections are randomly requested before rebate is mailed. Incomplete applications will be denied.

**\*Rebate amount cannot exceed cost of the pool cover (excluding taxes). Rebate amount is calculated at 25% of the material cost of the cover only, up to \$50. Limit one rebate per household.**
