## **\$150\* RESIDENTIAL HIGH-EFFICIENCY TOILET REBATE**

NMWD is offering residential customers up to \$150\* rebates for replacing older, non-water-conserving toilets (those that flush more than 1.6 gallons per flush) with new Ultra High Efficiency Toilets (UHET) that use 1.1 gallons per flush (on average for dual flush models) or less. These are more efficient models than the EPA Water Sense rated High Efficiency Toilets currently rebated by NMWD for up to \$100.

### **PROGRAM REQUIREMENTS**

#### **Applicants Must:**

- Purchase and install a qualified Ultra High Efficiency Toilet between January 1, 2021 and June 30, 2021. To see a list of qualified models visit [www.nmwd.com](http://www.nmwd.com) and refer to the UHET list.
- Own or rent a residential dwelling within the District's Novato or West Marin Service Areas. (If you are a renter, you need written permission from the owner to receive the rebate).
- Call or email the District's Water Conservation Office for participation details and to pre-qualify for the rebate.
- Replace **ALL** toilets that use more than 1.6 gallons per flush in the dwelling. (Customers changing toilets manufactured to flush 1.6 gallons per flush, or new toilets installed after 1993, will not be eligible for rebate)
- \$100\* rebate level good through June 30, 2021 or until funds are depleted. Completed application and receipts must be received by July 15, 2021.

#### **How can I participate?**

- Call or email the District's Water Conservation Office at **(415) 761-8944** or [waterconserve@nmwd.com](mailto:waterconserve@nmwd.com) for participation details and to pre-qualify. (Virtual during COVID-19)
- After you are pre-qualified with the District's Water Conservation Office, replace the toilet(s) with a qualifying Ultra High Efficiency Toilet. See qualified list on website.
- Mail in or drop off application along with original receipt for toilet(s) dated no earlier than January 1, 2021. Application must be **completed and signed**.
