## **\$100 Rebate for Self-Activated Hot Water Recirculation Systems**

North Marin Water District is currently offering a \$100 rebate to customers for self-activated or on-demand hot water recirculation systems only. Timer-controlled and thermostat-controlled systems are not rebated. A hot water recirculation system is a small water pump that works in conjunction with your hot water heater to more quickly provide hot water to the plumbing fixture (i.e.: shower/bath faucet, bathroom faucet or kitchen sink) most distant from the hot water heater. Unheated water left in the plumbing line is recirculated back to the hot water heater as opposed to running down the drain, thereby saving water.

Please read the Rebate Program Requirements below. Indicate the manufacturer name and model of the self-activated hot water recirculation system and the purchase price (excluding sales tax and labor) and complete the account and applicant information on the opposite side of this page.

### **PROGRAM REQUIREMENTS**

- Rebate application must be submitted within 90 days of item purchase. An original, dated sales receipt showing itemized costs for the rebated item must be provided.
- Applicant must own or rent a residential dwelling within the District's Novato or West Marin Service Areas.
- Applicant must install a system that is self-activated (i.e.: manually activated by a button, switch, or wireless remote). Timer-controlled and thermostatic-controller hot water recirculation systems do not qualify for the rebate.
- Installation of the rebated item is the sole responsibility of the applicant, as is determined by the adequacy and compatibility of the existing plumbing system. The applicant is solely responsible for proper disposal of all materials associated with the installation of the rebated item and NMWD assumes no responsibility or liability.
- Mail or drop off application with original receipts to District mailing address or office.
- A NMWD representative must be permitted to inspect the property to verify installation if requested.
- \$100\* rebate level good through December 31, 2021 or until funds are depleted. Completed application and receipts must be received by January 15, 2022.

### **How can I participate?**

- Install a qualified self-activated hot water recirculation system.
- Mail in or drop off, or email application along with original receipt for hot water recirculating system dated no earlier than May 1, 2021. Application must be **completed and signed**.

- Rebate payment will be mailed to you in 3-4 weeks after application with original receipts are received. Post inspections are randomly requested before rebate is mailed. Incomplete applications will be denied.
