## RESIDENTIAL WATER SMART LANDSCAPE EFFICIENCY REBATE

NMWD is offering residential customers a rebate of 50% to 75% of the actual cost of qualified water efficient landscape equipment and materials, excluding labor and taxes, up to a maximum of \$200 per household per 5-year period. Qualified products include:

- Drip irrigation systems – 75%
- Water pressure-regulating devices – 75%
- Check valves – 75%
- Multi-stream rotating sprinkler nozzles (for lawn areas only) – 75%
- Rain shut-off devices – 75%
- Soil conditioners/amendments (excluding chemical fertilizers/herbicides) – 50%
- Mulch – 50%

### PROGRAM REQUIREMENTS

#### Applicants must:

- Own a residential home within the NMWD's Novato or West Marin service areas.
- Agree to a brief pre- and post-installation inspection. (Virtual during COVID-19)
- Purchase and install the qualified products to be rebated between May 1, 2021 and December 31, 2021. Applications must be received by January 15, 2022.
- Be improving the landscape water efficiency of an existing landscaped area.

#### You are **NOT eligible** for the program if:

- You or a previous homeowner were issued a Landscape Water Efficiency Rebate in the past.
- Your dwelling is a commercial building or is owned by a commercial or government entity.
- Equipment and materials are part of a project involving other rebates from NMWD.

#### How can I participate?

- Step 1:** Call NMWD's Water Conservation Office at (415) 761-8944 and schedule a brief pre-inspection or receive pre-qualification over the phone.
- Step 2:** After pre-inspection of project is completed and project is approved, proceed with the landscape water efficiency project. **Rebates are issued only for projects approved in advance.**
- Step 3:** Schedule a post-installation inspection upon completion of project. (Virtual during COVID-19)
- Step 4:** Mail in or email your application along with receipts for materials dated no earlier than May 1, 2021. If you hire a contractor, ask for materials and labor to be itemized and billed separately.
