RECOMMENDED ACTION:

1) Hold Candidate Interviews for Board Director

2) Make an Appointment for Director

The following candidates provided a letter of interest prior to the deadline and are here tonight for interviews following the schedule below based on an alphabetic listing by last name.

Candidates will be given three to five minutes to make an opening statement. The remaining 15 to 20 minutes will be used for questioning from the Board using the attached interview questions (Attachment 1). The schedule provides a 5-minute gap between interviews enabling transition and some additional time should a particular candidate response need further clarification. The District Secretary will keep track of time and notify the Board and the applicant when one minute remains in the interview.

Upon completion of all interviews, the Directors will individually indicate their ranked first and second choices on a written ballot (Attachment 2) using a score of 2 or 1, respectively, after which points will be totaled for each candidate. The General Manager will tally the scoring and read it aloud. Should individual vote information be desired by the Board, the candidates or the public, it will be disclosed. Assuming that one candidate receives a sufficient score, this will prompt a Board member to make a motion for appointment. Appointment of a new Board member requires an affirmative vote by three directors. Once appointed, the District Secretary will swear in the new member (Attachment 3), under Agenda Item #3.

RECOMMENDATION

That the Board: 1) Conduct candidate interviews; and 2) Appoint a new Director.
