### THE POSITION

**North Marin Water District** is seeking a dynamic, strategic, and collaborative leader for its Treatment & Distribution Supervisor position. The Treatment & Distribution Supervisor plans, organizes and directs the operation of Water Treatment and Distribution at the Stafford Water Treatment Plant located in Novato, California.

North Marin Water District's Treatment & Distribution Supervisor oversees 6 Full Time positions and is responsible for a variety of functions, including being the Chief Operator for the District's potable treatment plants and distribution systems. This position supervises overall operation of all waterworks facilities required to treat, pump, store and distribute potable water, water and wastewater treatment plants, recycled water, aqueduct control, pumping stations, storage facilities and groundwater wells, and other water quality and regulatory related operations as assigned.

## **ABOUT US**

North Marin Water District's Stafford Lake, provides approximately 20% of Novato's water, lies four miles west of downtown Novato, CA and collects runoff from 8.3 square miles of watershed property located upstream at the upper tributary reaches of Novato Creek. Water from Stafford Lake is drawn by the intake tower and fed by gravity or by pumping (depending on the lake level) into the treatment plant located just below the dam. Russian River, which provides approximately 70% of Novato's water, originates in Mendocino County and derives supply from both the Eel River and the Russian River watershed.

North Marin Water District has 58 Full-Time employees and is comprised of four departments consisting of Accounting/ Finance, Construction/Maintenance, Engineering, Operations/Maintenance (which includes Water Quality)
