Discussion Items:

1. Introduction

The group went through brief introductions. Meeting attendees are listed above.

2. Strategic Plan Alignment

The Master Plan aligns with five action items from the 2025-30 Strategic Plan. Notably, Action Item 1.3 states to "leverage proven technology to establish a comprehensive asset management

- and preventative maintenance program." A hydraulic model (via ArcGIS) was used to analyze the system and develop the Master Plan recommendations.
- The Strategic Plan is an organizational document while the Master Plan is an infrastructurefocused document that develops the Capital Improvement Program (CIP) by evaluating the performance of the system given certain potential risk such aging infrastructure and natural hazards.

3. Part 1: District History

- The project team presented engineering aspects of the water system and how the system was historically planned. The system was sized using historical data for the consumption rate of customers and the maximum daily demand (MDD). The evolution of the water system was influenced by development. Novato's water system now includes Zone 1 (lowest elevation) through Zone 4 (highest elevation). A majority of the District's current pipeline assets were installed by developers in the 1950s and 1960s.
- The Board asked how District energy usage compares to Marin Municipal Water District. PG&E no longer shares its customer's use data, so staff cannot determine its relative energy usage other PG&E customers.

4. Part 2: Today's District

- Current demands are lower than projected in the previous Master Plan due to conservation efforts, recycled water delivery, and customer habits. The water system performs well but there are areas with hydraulic challenges, such as at the Lynwood Pump Station, which supplies a larger area of additional development as the system expanded south over time.
- The Board asked why the figure on slide 26 shows water from the Stafford Treatment Plant and the Russian River but not recycled water. The project team indicated that this current Master Plan includes a new chapter acknowledging recycled water as a separate source of supply. However, the information in this workshop focuses on potable water.
- Currently, the system, which includes pipes, pumps, and tanks, has adequate storage for today's needs. However, the system is starting to age. There are many pipes reaching the end of useful pipe life according to industry practices. To address the aging system, the project team indicated that the District should start considering replacement/renewal programs and increased capital investment. The risk scores show that the five facilities with the highest risk are all pump stations, which are critical for system operation.
- The group discussed the San Marin Pump Station, which is at a 6.81 risk score. It is currently sized to accommodate the new housing proposed at the old Fireman's Fund site without raising the risk score because the risk score was based on age and San Marin Pump Station has been retrofitted recently. Lynwood Pump Station and Cherry Hill Pump Station have not been retrofitted and will be prioritized in future plans. Through analysis of future demand, the system has the right amount of storage but will have challenges with delivering to customers with hydraulic efficiency.
- The group discussed the annual renewal need curve for pipelines and the importance of taking action to mitigate aging infrastructure. The curve will reach the peak in 2035 to 2040. The curve is based only on the industry's expected pipe lifespan and does not account for other conditions or variables that could either increase or decrease longevity.



- The group discussed the projected water pipeline replacement decade legend on slides 30 and 31
 to clarify what each color meant. The project team noted that clarification will need to be added
 to the figures included on slides 30 and 31 when those figures are included in the Master Plan.
- The Board mentioned they would need to consider whether the District would have the resources, such as cash (pay-as-you-go) and the ability to borrow, to replace pipelines over the long term. The project team added that although many pipelines were shown to be due for replacement soon, other factors could shed light as to which pipelines could remain in-service, such as condition assessments. In addition, the District's past practices implemented in the 1960's could extend life of pipelines, including using inert pipeline and bedding material to prevent corrosion, and quality inspection at installation.
- The group discussed procedures in major emergencies where the focus would be on critical
 customers, such as emergency shelters, and not typical residential customers. It would be a slow
 recovery process, potentially taking months before service to residential customers return to preemergency levels.
- The group discussed the Ridge Road Pump Station, which was determined as one of the most critical facilities. The pump station design is scheduled to start in the next two to three years and will be on the next CIP.
- The group discussed the process of determining critical facilities. The risk score calculations
 incorporated the use of several factors including age, number of customers served, and
 consequence of failure. The list of critical facilities shown during the presentation only considered
 pump stations and storage facilities; pipelines were not included.
- The Board asked if ArcGIS could track how many times a pipe's condition has been assessed. **Yes**, staff has developed a database that tracks this information.
- The Board mentioned that the public would benefit from the information presented in the
 workshop. The presentation will be made available to the public and will be a resource for future
 discussion with the public.
- The Board asked about the percentage of total water demand in Zone 1 and Zone 2. About 80% of the total demand occurs in Zone 1 and Zone 2.

5. Part 3: Preparing the District for the Future

- The next step of the Master Plan focuses on future work that includes addressing hydraulic
 deficiencies and the bell curve of pipeline renewal needs, which will continue to occur in
 perpetuity. The current CIP projects, shown on slide 37, only includes a small portion of the
 system.
- The project team presented the proposed water planning boundary, which is based on the
 Country of Marin and Novato zoning maps. The group discussed zoning in the old Fireman's Fund
 area. The project team noted that the hydraulic zone has not been determined yet, but it might be
 in one or two zones. Even if the new water infrastructure is paid for by the developer, it may
 become the District's asset and long-term liability.
- The backbone assets are considered the most critical assets, which will have the largest impact on
 the largest number of customers in event of a failure including the ability to supply other pressure
 zones. Other improvement projects could consider how to improve operational strategies and
 resiliency projects to address projected sea level rise, flooding, and seismic risk. The Board
 commented that seismic activity has been extremely low.



- Meeting participants discussed potential future costs. The quantity of improvement is a major driver for increased costs. Pump stations often need full replacement since electrical gear cannot be reliably retrofitted. Potable water pipelines generally require full replacement. Tanks can be retrofitted cost-effectively. The District would need to look at assets on a case-by-case basis to better determine future costs.
- The group discussed the cost of the Lynwood Pump Station (\$8 million to \$12 million) and Crest Pump Station (\$1.5 million), both of which include relocation of an existing facility. The Lynwood Pump Station cost is higher due to the several thousand feet of pipe required to address the hydraulic challenges as well as a larger PS structure and equipment size. Crest Pump Station is smaller and more in line with a majority of the District's pump stations. The remaining facilities would not require relocation, so land acquisition is not considered in this Master Plan`.
- The project team indicated that when looking through the bell curve lens, the District would need to start replacing several miles of pipe per year starting in the next five years and up to 10 miles per year at the bell's peak which is estimated to occur in about 20 years. The replacement rate would start to decline in subsequent years. The Board acknowledged that the current water rate structure does not cover this forecast in pipeline replacement costs.
- The Board continued the discussion about funding. Currently, the District only charges user fees to
 maintain the 350 miles of pipe. Funding strategies discussed include extending the model of user
 fees to include capacity fees, a capital charge, or a bond measure for capital improvements. The
 pay/go was increased from \$1.5 million to \$4 million several years ago.
- The project team presented the investment strategy where the most critical infrastructure, including pump stations and high-risk pipelines will be the priority.
- The project team clarified that the near-term draft CIP annual expenditure presented in the Master Plan will be presented during a future Board presentation.

6. Further Discussion

- The group continued to discuss funding. There is one more rate year remaining from the previously approved Novato rate structure. Once the long-term CIP is developed, District staff will be able to incorporate the proposed CIP into next rate study and financial model. The group also discussed how a bond measure would affect property owners and residents or renters and whether a pay/go increase in the next year rate study would be possible given the forecasted increase in infrastructure renewal. Any increase to the annual pay/go would likely take another rate study cycle. The Board will continue to have future discussions about different funding options.
- The project team noted one thing to consider is whether the District's approach with managing
 future risk needs to change. The District has already begun to discuss internally various options to
 support an increased CIP investment, including potentially hiring more Full-Time Equivalents
 (FTEs) employees and/or leveraging consultants. Another consideration is how to set the District
 up for future success, which will be discussed at future Board meetings.
- The Board agreed that public education will be important in the Strategic Plan. The Board noted
 that it is important to maintain the District's integrity and present the information to the public in a
 way that is transparent and informative. The Board suggested that Staff meet with an outside
 vendor with PR expertise to discuss infrastructure replacement strategy messaging.
- The Board also discussed messaging to the public. Messaging can include that tanks or pump stations need to be continually maintained, similar to painting the Golden Gate Bridge, and that proactive maintenance and replacement would result in a better system for the next generation.



- The Board noted that West Marin just had another large fee increase, with limited feedback from
 customers. It is possible the public may already realize the need to increase spending to replace
 aging infrastructure. A possible method for getting the message out could be writing a column for
 the Marin Independent Journal. At the next Board meeting, the Board will start discussing what to
 do to start communicating this to the public.
- Staff mentioned that action to fund the new CIP can kick off once the Master Plan is complete. There will be another presentation focused on the technical aspects of the Master Plan before Board acceptance, which District staff is planning for January 2026. The meeting for Board acceptance could be an opportunity to begin the public education campaign.
- The Board suggested that the project team create CIP alternatives based on various funding scenarios.

Director Eichstaedt asked how the goals will be tracked internally and Mr. Williams said we have a tracking document that has action assignments by the applicable department. It will be discussed at regular Senior Staff and Department Head meetings as well as quarterly all staff meetings. He said that the Plan will be hosted out on the website and actions on specific projects will also be uploaded when appropriate.

INFORMATION ITEMS

CALPERS PENSION UPDATE 2025

Julie Blue provided a summary highlighting key points from the memo, noting that pension updates are presented to the Board annually. She explained that the District offers a defined benefit pension plan with two membership classifications: Classic and PEPRA. PEPRA was established under the California Public Employees' Pension Reform Act (PEPRA) of 2013. Currently, the District employes 34 PEPRA members and 24 Classic employees. Ms. Blue noted that for FY25/26, employer contributions increased by 2% compared to the prior FY due to an increase in payroll and increase in the unfunded liability allocated to the District's plan. President Joly asked if we looked at other agencies and their funded ratio percentages and Ms. Blue said that 34 other agencies were surveyed. She said that 11 agencies were below 70% funded and 8 were above 90% funded. President Joly thanked Ms. Blue.

NBWA MEETING AGENDA – OCTOBER 10, 2025

Director Fraites gave a summary of the meeting he attended. He said the main speaker was very interesting, and that the group is a non-profit dedicated to the honeybee population. Last year

FINANCIAL IMPACT: None

OPERATIONS

The Operations Group completed a variety of tasks and executed projects in FY 2024-2025. Operations staff completed over 415 routine maintenance tasks; and staff completed 12 storage tank cleanings.

Four major improvement projects were completed. There were three projects completed at Stafford Treatment Plant; the filter underdrain replacement, the change-out of the filter media, and the replacement of High Service Pump #3. There was one major project completed in West Marin; the upgrade of Gallagher Well #2 pump and motor due to higher well production.

The following is a breakdown of supply, production, and demand data for FY 2024-2025, pertaining to the different service areas.

Novato Water Service

- Stafford Lake reached capacity on December 16, 2024, and spilled until the beginning of May.
- Stafford Treatment Plant produced 309 million gallons (MG).
- Novato total demand was down 2.2% from the previous year.
- Novato average daily demand was 6.4 million gallons per day (MGD).
- Novato peak day demand was 11.09 MGD, on May 20, 2025.
- Purchased recycled water was 266 MG, up 30% from last year.

Attachment 1 is provided showing the total water use for the Novato Water Service Area.

West Marin Water Service

- West Marin water demand was up 13%.
- West Marin average daily production was 215,918 gallons per day (gpd).
- West Marin peak day demand was 369,220 gallons.

Oceana Marin Wastewater Service

- Force main pump flow average was 16,860 gpd.
- Force main pump peak day demand was 86,480 gallons.

MAINTENANCE


The Maintenance Group was also able to complete a wide variety of tasks and projects in FY 2024-2025. Maintenance staff completed over 237 routine maintenance tasks. Staff completed 25 facility improvement projects. Crest Tank had the power upgraded in anticipation of a future project related to hydro-pneumatic capital project. The new Crest Pump Station and Programmable Logic Controller (PLC) were commissioned and put into service. Variable frequency drives (VFDs) were installed on the Lynwood Pump Station pumps. Two new submersible level sensors were installed in the Oceana Marin wet well. The PG&E meter panel was replaced at the Point Reyes Treatment Plant. Staff coordinated with the Cla-Val maintenance crew to replace 23 pressure regulating valves and service an additional 16 pressure regulating valves. Trees were planted at San Marin Pump Station to screen the new battery backup system, and annual vegetation management was completed.

As part of the Cross Connection Control Program, testing was completed on all but 42 of 2,476 potable backflow devices (2,375 in Novato and 101 in West Marin). Twenty-six percent of Novato Recycled Water accounts were inspected and tested, with no cross connections issues found. The inspection and test includes a site review of recycled water use, overspray and leaks, and a shutdown of both the potable and recycled water service to verify that neither of the services supply water to the other.

The State Water Resources Control Board has implemented new regulations regarding Cross Connection Control policies. NMWD Cross Connection Control policy update recommendations will be brought to the Board of Directors in the coming months.

FINANCIAL IMPACT: None

At month end, the District's Investment Portfolio had an amortized cost value (i.e., cash balance) of \$21,470,924 and a market value of \$21,495,366. During September, the cash balance increased by \$1,094,915. The market value of securities held increased \$1,104,178 during the month. The total unrestricted cash balance at month end was \$605,213, 71% of the Target Reserves are funded and 102% of the Minimum Reserves are funded.

At September 30, 2025, 59% of the District's Portfolio was invested in California's Local Agency Investment Fund (LAIF), 24% in Time Certificates of Deposit, 5% in the Marin County Treasury, and 12% retained locally for operating purposes. The weighted average maturity of the portfolio was 91 days, compared to 104 days at the end of August. The LAIF interest rate for the month was 4.21%, compared to 4.25% the previous month. The weighted average Portfolio rate was 3.62%, compared to 3.81% for the prior month.







Forecast Informed Reservoir Operations at Lake Mendocino

In 2014, federal, state, and local agencies partnered with scientists to explore how weather forecasts could support reservoir management at Lake Mendocino.

This collaborative effort resulted in Forecast Informed Reservoir Operations (FIRO), pioneered here in 2020 and officially incorporated in Lake Mendocino's Water Control Manual in 2025. Following this success, FIRO is now improving how reservoirs are managed across the western United States and beyond.


Innovation in Water Management

FIRO enables water managers to use weather and streamflow forecasts to guide their decisions.





With increased lead time before a major storm, operators can safely release water to make room for incoming flows. When forecasts indicate dry conditions ahead, operators can retain more water in the reservoir for future use. FIRO is a landmark innovation that makes reservoir operations more resilient and responsive to weather variability.



FIRO has now been implemented temporarily at Lake Sonoma as well Lake Mendocino. Between 2022 and 2025, FIRO has helped both reservoirs retain more than 90,000 additional acre-feet of water cumulatively.

That's enough water to fill 36,000 Olympic-sized swimming pools – nearly the total capacity of Lake Mendocino itself!

As tribal leaders, farmers, ranchers, and residents of the Russian and Eel River communities, we write today to express grave concerns regarding Pacific Gas & Electric Company's (PG&E) proposed surrender and decommissioning plan for the Potter Valley Project (FERC Project No. 77), submitted on July 25, 2025.

For over a century, the Potter Valley Project has provided reliable electricity and water to over 750,000 residents across four counties from Potter Valley to Marin County, and its Lake Pillsbury even helped extinguish two of the three largest fires in California history. Specifically, the proposed dam removals of the Potter Valley Projects' Cape Horn and Scott Dams threaten our region's water supply, economic stability, and even our environment. While we support reasonable environmental permitting, preserving critical water infrastructure is existential. We therefore urge a full and thorough review of the decommissioning's impacts, especially with respect to dam removal in California.

PG&E's plan identifies "unavoidable adverse effects" from decommissioning. However, the process lacks transparency, meaningful stakeholder engagement, and adequate mitigation plans. Despite PG&E's claims of consulting resource agencies and tribes, several tribes including the Potter Valley Tribe were removed from discussions or not consulted, and it appears other agencies tasked with protecting Russian and Eel River resources were similarly excluded.

Hydrological and Environmental Impacts

Decommissioning will halt summertime diversions to the East Branch Russian River, devastating the Russian River watershed's water supply, destabilizing flow regimes, and raising water temperatures during critical spring and summer months. Dam removal will release turbidity, sediment, and nutrients, degrading water quality, reducing dissolved oxygen, and fostering algal blooms. These impacts will extend downstream through the Eel River, its estuary, and the near-shore ocean, with effects lasting years.

Aquatic species, including Endangered Species Act (ESA)-listed Chinook salmon, steelhead, Pacific Lamprey, Foothill Yellow-Legged Frog, Pond Turtle, Western Pearl Shell Mussels, and Green Sturgeon, face immediate risks from sediment-driven habitat loss, non-native fish releases, and direct mortality. The Russian River will lose habitat for special-status amphibians and mussels, undermining ecological protections. These species hold cultural significance to several area tribes, amplifying the need for careful consideration.

Botanical resources, including eelgrass, riparian, and wetland habitats, will be disrupted. Wildlife such as Bald Eagles, Ospreys, Northern Spotted Owls, Waterfowl, Tricolored Blackbirds, and Tule Elk will face habitat loss, noise disturbance, and displacement. Groundwater wells, downstream infrastructure, and water intakes are also at risk.

Wildfire Fighting Concerns

The reservoirs of the Potter Valley Project are critical for wildfire suppression in the region, providing accessible water for firefighting efforts. Their removal would severely hamper the ability to combat wildfires, increasing risks to lives, property, and ecosystems. We request immediate consultation with the United States Forest Service (FS) to assess the reservoirs' role in wildfire management and to ensure that decommissioning does not compromise regional fire suppression capabilities.

Human and Cultural Impacts

Decommissioning will eliminate recreational opportunities at Lake Pillsbury, reduce agricultural productivity, and alter the character and economy of the Eel and Russian River watershed communities. Tribal cultural resources

face significant impacts without proper consultation, violating legal requirements. The rushed process disregards stakeholders who will bear the consequences, trading one set of environmental harms for another while imposing severe costs on people, wildlife, and ecosystems.

Legal and Regulatory Failures

- 1. Clean Water Act (Sections 401 and 404): PG&E has not demonstrated how communities will be compensated for unavoidable impacts or ensured water quality, particularly for Lake Mendocino, affected by upstream dam removal. A U.S. Army Corps of Engineers (USACE) permit and state water quality certification are required.
- 2. Endangered Species Act: FERC must conduct a biological assessment and consult with the Services to mitigate harm to listed species. PG&E's admission of "direct loss" of aquatic species, including 168.5 miles of the Eel River below Scott Dam, necessitates significant modifications.
- 3. Magnuson-Stevens Act: Impacts on essential fish habitat require a FERC and National Marine Fisheries Service (NMFS) consultation.
- 4. National Environmental Policy Act (NEPA): The project's significant environmental impacts require an Environmental Impact Statement (EIS) to evaluate water quality, fisheries, wetlands, wildlife, sediment transport, and community impacts. A "no-action" alternative must be considered as the least damaging option.
- 5. National Historic Preservation Act (Section 106): PG&E has not assessed impacts on historic sites. The Area of Potential Effects (APE) remains undefined, risking damage to California Coast Ranges' cultural resources.
- 6. Coastal Zone Management Act: The plan violates California's Coastal Management Program by harming marine resources, water quality, and sensitive habitats.
- 7. Federal Dam Safety Guidelines: PG&E lacks a comprehensive risk assessment and Emergency Action Plan (EAP) for decommissioning, ignoring risks like uncontrolled water flow, sediment release, and slope instability.
- 8. Department of Energy and Clean Hydropower Concerns: The decommissioning eliminates a reliable source of clean hydropower, undermining national energy security goals. The Potter Valley Project's renewable energy contribution supports grid stability. We urge consultation

- with the Department of Energy to evaluate the loss of this critical energy resource.
- 9. Resource Conservation and Recovery Act (RCRA): PG&E has not assessed accumulated sediment for toxic contaminants. If hazardous, strict RCRA regulations and potential CERCLA cleanup apply.

PG&E's decommissioning plan is inadequate, non-compliant with federal law, and dismissive of community and environmental consequences. We urge the Commission and cooperating agencies to reject the plan in its current form and facilitate a transparent, science-driven process that includes robust stakeholder consultation. Numerous tribes, along with communities of both the Eel and Russian River watershed, have relied on this project for generations; we should not bear the costs of a flawed plan. We call on you to halt this reckless action until a lawful, transparent, and alternate path is established.

m. Description of Request: On July 25, 2025, Pacific Gas and Electric Company (PG&E) filed a surrender application, in which it proposes to surrender and decommission the Potter Valley Project. As a condition of surrender, PG&E also

requests the Commission approve its application for non-project use of project lands, which would allow the Eel-Russian Project Authority (ERPA) to construct a New Eel-Russian Facility (NERF) on project lands. This NERF would allow for the continued diversion of flows from the Eel River watershed to the Russian River watershed via certain project works post-surrender.

Specifically, PG&E proposes to: (1) decommission and remove Scott Dam and its associated facilities; (2) remove licensed recreational facilities (e.g., campgrounds, day-use facilities, kiosk, and boat ramps) and restore associated U.S. Forest Service (Forest Service) and PG&E lands; (3) decommission and remove Cape Horn Dam and its associated facilities and features, except for those necessary for the NERF; (4) remove NERF facilities and lands from the existing license; and (5) restore the remnant inundation zone of Lake Pillsbury reservoir and Van Arsdale Reservoir, including adjacent riparian, wetlands, and upland areas affected by decommissioning the project as proposed.

MMWD secures deal on supply

15-year pact locks in Russian River water

A 15-year water supply agreement between agencies in Sonoma and Marin counties has received final approval.

Under the agreement, the Marin Municipal Water District will pay \$12.5 million to the Sonoma County Water Agency to boost regional drought resiliency. The agreement replaces previous contracts and establishes the terms for how Russian River water is delivered to Marin County through 2040.

Marin Municipal Water District officials approved the contract at a meeting in August. The board governing the Sonoma County agency solidified the agreement on Tuesday.

"This agreement is an important step forward for regional collaboration and long-term water reliability," said Jed Smith, a board member of the Marin Municipal Water District. "We appreciate Sonoma Water's partnership and commitment to shared solutions."

About 75% of the Marin Municipal Water District supply comes from the Mount Tamalpais watershed and hills of West Marin. The district's seven reservoirs have a combined storage capacity of about 80,000 acre-feet of water. An acre-foot is about 326,000 gallons. The district serves about 191,000 residents.

The rest of the water comes from the Russian River watershed, managed by the Sonoma County Water Agency.

The two districts have had a series of agreements in place since 1975. The new contract restates agreements from 2015, consolidating them into a single contract. The 15-year term was reached to align better with the Sonoma County agency's other water customers.

Sonoma County Water Agency officials said the updated agreement simplifies delivery rules, removes outdated provisions and adds flexibility.

Just as before, the contract commits the Marin district to purchase at least 5,300 acre feet of water, but no more than 14,300 acre feet a year.

Marin Municipal Water District officials said the contract includes a few amendments that will support the agency's "atmospheric river capture" project, the proposed pipeline that will carry Sonoma County water to Nicasio Reservoir. The pipeline project aims to boost Marin's supply during droughts.

Specifically, the Marin district will now be able to roll over any undelivered water to the following year if the Sonoma agency is unable to transport the "take-or-pay" minimum of 5,300 acre-feet.

The contract also drops older requirements that tied purchases based on the prior year purchase amounts.

Marin Municipal Water District's payment includes \$9 million for water resiliency projects in the Russian River watershed. The remaining \$3.5 million will support the Sonoma agency's effort to improve the delivery of water collected during the rainy months to Marin County.

Lynda Hopkins, chair of the Sonoma County Water Agency board, said the North Bay water systems are tightly connected.

"This agreement keeps that partnership strong, gives both counties more flexibility in dry years and directs new investment into projects that make our regional supply more reliable," Hopkins said.

The North Marin Water District also receives a significant portion of its water from the North Bay neighbors. About 80% of its water comes from Russian River imports through the Sonoma agency, with the remainder coming from its own Stafford Lake reservoir.

Stafford Lake in Novato is typically only tapped during peak summer months, when water use can sometimes double. The North Marin Water District serves about 60,000 residents in the greater Novato area as well as about 1,800 residents in areas of western Marin.

The contract between Marin Municipal Water District and the Sonoma County Water Agency does not affect the North Marin Water District supply, said Tony Williams, general manager of NMWD.
